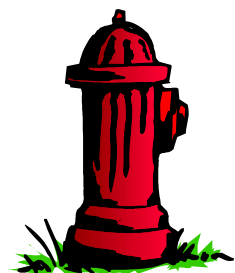

Directions to Frenchmen's Bar Riverfront Park

This park is approximately 7 miles from the I-5 4th Plain exit.

From I-5 North take (Exit 1D) 4th Plain. Turn left at the signal at the top of the off ramp. You will be heading west on 4th Plain.

From I-5 South take (Exit 1D) 4th Plain. Veer to the right just before the signal. You will be heading west on 4th Plain.

Continue west on 4th Plain. You will cross over a bridge that spans a railroad yard. You will need to get into the left lane before the next signal, which is Fruit Valley Rd. After crossing Fruit Valley Road you will veer to the right before the signal where Mill Plain and 4th Plain meet. You will be going west on SR 501. The name of the road will change to Lower River Road from 4th Plain. Continue on this road. The road will take a hard left turn (90 degree - do not go into the Vancouver Lake Park) and then a hard right (90 degree). Go a short distance and turn left into the park. The sign says "Frenchmen's Bar Riverfront Park". We will be in the second parking lot.
