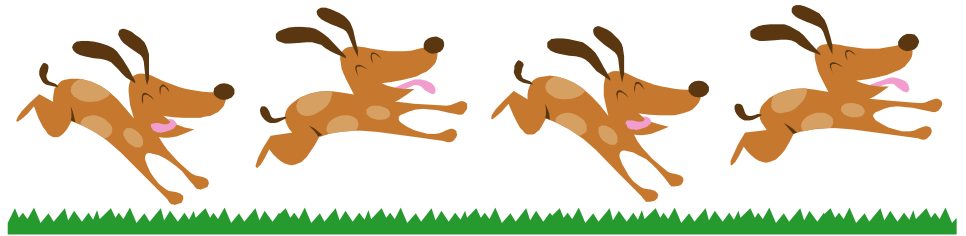

How to Get There from I-205

Take I-205 to the Stafford Rd exit.

If you came off of South-bound I-205, turn left onto Stafford Rd.

If you came off of North-bound I-205, turn right onto Stafford Rd.

In any case you should be driving away from Lake Oswego.

Drive .9 miles to Mountain Rd, turn left.

Drive 3.7 miles on Mountain Road to Hoffman, turn left.

Drive .8 miles on Hoffman to Riverwood, turn right.

Drive .6 miles on Riverwood to the BIG Riverbend sign. Bear right on to Hebb Park Road.

Keep bearing right as you drive up the hill only .1 miles to the BIG Riverbank sign (It's a line of BIG rocks with a steel letters on the front). Bear left onto Riverlane Rd.

Follow Riverlane Rd around the circle to 30940 SW Riverlane Rd. House is on the left, it's beige, with two 2-car garages.
