Meeting Minutes February 18, 2011 at Legacy Hospital, Tualatin, OR.

The meeting was called to order by VP Judy Chambers at 8:55 PM after the presentation on stud dog management by Cheryl Lopate. Motion by Ellen Sparks and seconded by Cindy Freeman to waive the reading of the minutes of the last meeting. Judy noted that Barb was presently becoming a grandmother. Judy asked for interest in seeing a stud dog collected and said she would set up a time for this. It was also suggested that we could have Cheryl Lopate back to discuss whelping. Judy will try to set this up for fall.

Old business: Nikki spoke of changes in dog training laws proposed by Oregon Dept. of Wildlife. They are having an advisory meeting March 7th from 10-2 pm in Salem. This is related to the House Bill that will affect HRT. People working at the HRT will need a state stamp, hunting license, etc. and will be limited to the number of birds used. Nikki will get this information to Celeste for the newsletter. Judy will get information to Celeste from the National Animal Alliance regarding private land owners doing agility training, It was suggested that Patty Strand could possibly speak to this issue at an upcoming

meeting. Sweatshirts were brought up, Celeste in charge of this.

New business: Judy said that we had a new panel of judges from the January meeting for the 2012 specialty, but we have no chairman to contact them. Cindy Freeman volunteered to contact the judges since she has the letters and contracts on her computer. We will ask for volunteers to head the 2012 specialty in the newsletter.
